Linda L. Matz: Resignation

Motion to accept the resignation of Linda L. Matz effective August 31, 2011 offered by D. Kelley second by B. Kelley was approved per a roll call vote 6-0 Matz abstained

- Hail Cannon: It is within the rights for an Orchard to use the Hail Cannon as long as it isn't used for harassment.
- 2011 tax millage: 0.7750 mills

Motion to approve the millage 0.7750 for the 2011 tax year offered by Dean second by Matz was approved per a roll call vote 7-0

#### **BOARD COMMENTS:**

- Matz: Newsletter articles should be submitted to Matz no later than June 30, 2011 in digital format.
- Matz replacement: Matz reminded the Board in the past; when an elected official left office the job was offered to the Deputy. There was much discussion regarding Brooke Mauric. The Board asked her if she was interested and could do he job. She said she would make Oakfield her priority; she would make it work.

Motion to approve Brook V. Mauric to take over the Clerk's position effective September 1, 2011 offered by B. Kelley second by Rittersdorf was approved per a roll call vote 6-0 Matz abstained

• Clerk Training: Matz stated that Mauric will need training; she has worked on the QVF but not the balance of the job. Her Deputy wage only covers 4 hours a week.

Motion to pay Mauric \$12.50 an hour for training starting August 1<sup>st</sup> for 16 hours a week; not counting the August election on the 2<sup>nd</sup>. Offered by D. Kelley second by B. Kelley was approved per a roll call vote 6-0 Matz abstained
