PURPOSE OF MEETING

 - Recommendations: Auto stop/ return mechanisms on the main bay doors.
 - Chief to read "Risk Management is good management" on line.
 - Two bids for Auto stop/ return mechanisms in the amount of \$1,422.00 from Overhead door and \$685.00 from Greenville American Overhead door.

Motion to approve the bid from Greenville American Overhead door in the amount of \$685.00 offered by B. Kelley second by Rittersdorf was approved per a roll call vote 7-0

- Riker went through the Fire Department Budget
 - Discussion on: Firefighter salary, Building maintenance and repairs, Education, still working on prices for physicals and contribution to the county.
 - Discussion on when the firefighters get paid an hourly rate.
 - Fire Runs + 1 hour clean up for those that participate.
 - Rescue; time on run.
 - Class training at the accredited rate. (6 hour class is 6 hours pay)
 - Computer Class (National Registry) cost of the class only.
 - Three Thursday nights a month 2 hr class each.
 - One Saturday a month; 6 to 8 hour class.
 - Smokehouse is voluntary, no pay.

- 2. Rescue; time on run.
- 3. Class training at the accredited rate. (6 hour class is 6 hours pay)
- 4. Computer Class (National Registry) cost of the class only.
- 5. Three Thursday nights a month 2 hr class each.
- 6. One Saturday a month; 6 to 8 hour class.
- 7. Smokehouse is voluntary, no pay.

Motion to pay Firechief 7 days vacation after one year offered by D. Kelley second by Rittersdorf was approved per a roll call vote 7-0

Motion to bring Wage Resolution of \$21,000. for the Treasurer, Clerk and Supervisor to the February Board meeting offered by Dean second by D. Kelley was approved per a roll call vote 7-0
