# APPROVAL OF MINUTES:

<u>Motion</u> to approve regular meeting minutes for October 11, 2022, offered by Koett second by Riker approved per a voice vote 5-0, Sowerby abstained.

Treasurer informed the Board that the Township received another State of Michigan revenue sharing check on the 2<sup>nd</sup> of November in the amount of \$122,087.00.

Motion to approve Scram Lake expenditures for the month of October 2022 in the amount of \$7,401.59 offered by Koett second by Rittersdorf approved per a roll call vote 6-0.

Deputy Assessor Posting-Had 2 candidates apply. 1 Never returned the Assessor's phone call to set up a time for an interview. The other candidate-Ben Albin is certified and accredited. The Assessor recommended that we hire him.

Motion to approve hiring Ben at \$15.50/hour to work 2 days/week on Tuesday and Wednesday offered by Dean second by Sowerby approved per a roll call vote 6-0.

- Horseshoe Lake Dam Project-Haven't started it yet. Set up signs on 11/10/2022. Dean called Jerry Burns at the Road Commission to have him tell the Drain Commission to get started.
- Podunk Dam Project-This is a go to start sometime this month. Extending the berm.
- Building at Scram Lake Drain Field- Dean checked on purchasing a shipping container at a cost of \$3,000 but there isn't really any room for it. To put up a building would cost \$6,000. However, if we clean out the pole barn behind the Township offices we would have room for the items to be stored in it.

### **NEW BUSINESS:**

Child Care Ordinance Amendment-Planning Commission recommended to pass it. Ordinance #111022.

Motion to adopted the Child Care amendment offered by Dean second by Koett approved per a roll call vote 6-0.

Prien & Newhof Services Agreement-Have done business with them for years. They have a change at their office so we need to renew our service agreement with them.

Motion to approve to continue to use their services offered by Koett second by Sowerby approved per a roll call vote 6-0.

Road paving informational meeting for Wabasis & Mac Clain November 9, 2022 @ 7pm-Had meeting and only 10 people showed up. They are all for having it done. The meeting went well. There will be a county hearing regarding it on the 10<sup>th</sup> of December.
